NLTN Privacy Policy

“NLTN” (“us”, “we”, or “our”) operates the <http://nltntct.com> website (the “Service”).

This page informs you of our policies regarding the collection, use and disclosure of Personal Information when you use our Service.

We will not use or share your information with anyone except as described in this Privacy Policy.

We use your Personal Information for providing and improving the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, accessible at <http://nltntct.com>

Information Collection And Use

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to, your name (“Personal Information”), email or phone number.

A Google Analytics Tracking Code is installed to gather data in order to improve our website and user experience.

A tracking pixel for remarketing purposes (Facebook or other services ONLY GDPR compliant) might also be installed in order to provide our users with more accurate and personalized offers and content.

The tracking is anonymous and we don't go beyond what 3rd party apps like Google, Facebook, or other GDPR compliant services allow us to do. We are limited to their functionality and their compliance with the law and use the data we capture using their services to improve the experience on our site and provide more accurate and personalized information to you.

You have a lot of rights regarding your data like being informed about what we do with it (this page), access personal information and customize it or delete it from our database (unsubscribe or manage lists).

Sing-up Forms

Log Data

Cookies
